The College of the Mainland Basic Peace Officer Academy has scheduled a start date for the Basic Peace Officer training program.

The attached application packet contains information on the minimum standards for admission to the Academy. Please review the enrollment and licensing standards closely to ensure that you qualify.

This is a preliminary application only; class space is limited, and application does not ensure acceptance.

Students must also apply to College of the Mainland. This is a separate application. The College of the Mainland Application can be found at com.edu.

Apply to College of the Mainland to be accepted as a student at <u>www.com.edu</u>. Select Apply Now in the top red banner.

Priority for acceptance will be given to current law enforcement employees.

You will be notified of your acceptance prior to the start of the Academy.

Application materials such as the attached pre-enrollment basic licensing course background criminal history check, psychological testing, drug testing, Meningitis Vaccine, and physician's medical opinion form must be completed at the applicant's expense.

Do not turn in application to the Academy until this entire document is completed.

This document must be returned to the front office of the Public Service Careers Department.

PERSONAL HISTORY STATEMENT

All applicants are required to turn in a Personal History Statement (PHS) with their application. The PHS is a TCOLE requirement required for entrance into the Academy.

- 1. The PHS is an exceptionally large document; <u>start it as soon as you are able</u>. This can take up to two weeks to fill out.
- 2. Integrity is of the utmost importance -be as honest and precise as possible.
- 3. If there is information you cannot remember, do not leave blank- write that you cannot remember or other explanation for not having the information.
- 4. If there is a field that does not apply to you, <u>write NA in the blank</u>. Do not use this if there is information that applies that you that you do not have access to.
- 5. For information you do not have access to, please write UTO in the blank for unable to obtain.
- 6. Do not leave any fields empty.
- 7. Print your PHS single sided. <u>Do not print double sided</u>.
- 8. The PHS can be filled out electronically or by hand. If you fill it out by hand, use a black pen only. Print legibly. Typing your answers is preferred.

- 10. The PHS must be initialed on the bottom of every page.

TEXAS COMISSION ON LAW ENFORCEMNT (TCOLE) REQUIREMENTS

The Basic Peace Officer Course (BPOC) in the College of the Mainland Law Enforcement Training Center is governed by the laws and regulations of the State of Texas, the Texas Commission on Law Enforcement, College of the Mainland and internal LEA standards and practices approved by the Law Enforcement Academy Advisory Board.

The amount of material in this application may appear daunting but it is necessary to ensure that cadets meet the criteria for licensure by the State.

College of the Mainland is an accredited College and Academic Provider of Law Enforcement Training.

Academic provider--A school, accredited by the Southern Association of Colleges and Schools or its successors and the Texas Higher Education Coordinating Board, which has been approved by the commission to provide basic licensing courses.

(3) Accredited college or university--An institution of higher education that is accredited or authorized by the Southern Association of Colleges and Schools, the Middle States Association of Colleges and Schools, the New England Association of Schools and Colleges, the North Central Association of Colleges and Schools, the Northwest Commission on Colleges and Universities, the Western Association of Schools and Colleges or its successors, or an international college or university evaluated and accepted by a United States accredited college or university.

College of the Mainland cannot accept any student to the LEA that does not meet TCOLE Licensing standards.

TCOLE States:

Sections 1701.251 and 1701.253 of the Texas Occupations Code (TOC) requires that TCOLE draft, implement, update, and regulate preparatory and continuing education courses for every type of law enforcement license it regulates. The Commission administers said training mandates through authorized law enforcement academies (LEA's) and approved contractual training providers. A list of all training mandates is readily accessible on the TCOLE website.

Section 1701.255 of the TOC requires that TCOLE establish minimum qualifications for enrollment in any basic licensing course. This section specifically prohibits the enrollment of an individual who does not meet the minimum requirements stipulated under Rule 217.1.

Section 1701.304 of the TOC requires successful completion of a licensing exam for any license issued by TCOLE. Eligibility requirements to take licensing examinations may be found in Section 219.1 of the Administrative Rules.





Basic Training Requirements

Peace Officer

Peace officer applicants are required to successfully complete the current Basic Peace Officer Certification courses (#1000696) and pass the licensing exam prior to being licensed.

DISQUALIFICATIONS FROM ACADEMY

Disqualification for Licensure – Criminal Conviction

Section 1701.312 specifically disqualifies a person from being licensed as an officer, county jailer or telecommunicator if the person has been convicted of a felony offense. A felony conviction exists if the person has been adjudged guilty of a felony offense under the laws of Texas, another state, or the United States Code. Further, Chapter 217.1 disqualifies a person who has been convicted of a Class B Misdemeanor offense for a period of 10 years and a person convicted of a Class A misdemeanor for life. Waivers are obtainable 5 years after conviction, under certain circumstances, for misdemeanor offenses, and are addressed in Rule 211.30.

A person adjudged guilty of a disqualifying offense but placed on probation is for all licensing purposes considered to be <u>convicted</u>. Key phrases like "adjudged guilty" or "found guilty" are a clear indication of a permanent conviction. This type of adjudications will be treated as convictions regardless of whether: (1) the sentence is subsequently probated, and the person is discharged from community supervision (aka "*deferred adjudication*"); (2) the accusation, complaint, information, or indictment against the person is dismissed and the person is released from all penalties and disabilities resulting from the offense; or (3) the person is pardoned for the offense, <u>unless</u> the pardon is granted expressly for subsequent proof of innocence.

Under current Federal Statutes (U.S. Code, Title 18, Crimes and Criminal Procedure, Part 1, Crimes, Chapter 44, Firearms, Sections 921(a)(33)(A)&(B), and 922(d)(g)&(h)) a person convicted of any crime involving domestic violence or subject to any type of restraining order issued by a court of competent jurisdiction is prohibited from owning or possessing firearms or ammunition – which automatically disqualifies the individual from being licensed as a peace officer. Furthermore, administrative rules prohibit the issuance of any TCOLE license to a person convicted of an offense which involved family violence.

Section 1701.553 of the Occupations Code makes it a state jail felony to appoint or retain a convicted felon (see also sections 1701.312 and 1701.313). It is also a criminal offense to knowingly make a false statement on <u>any</u> TCOLE license application.





BASIC PEACE OFFICER ACADEMY ENROLLMENT STANDARDS

Enrollment Standards: Individuals interested in attending the Basic Peace Officer Academy must meet all the below listed enrolment standards.

The Texas Commission on Law Enforcement Standards and Education establishes these standards and does not provide for any exceptions. <u>The complete TCOLE Rules and Regulations for entrance into a Basic</u> <u>Peace Officer Academy are listed later in this packet and must have been read</u>. The below listed requirements is a general synopsis and subject for modification by TCOLE:

Applicant: Must be 21 years of age, or 18 years of age if the applicant has received an associate degree or 60 semester hours of credit from an accredited college or university or has received an honorable discharge from the armed forces of the United States after at least two years of active service;

Must have a high school diploma, or high school equivalency certificate. Received an honorable discharge from the armed forces of the United States after at least 24 months of active-duty service.

Subjected to a search of local, state, and national records to disclose any criminal record.

Must not ever have been on court-ordered community supervision or probation for any criminal offense above the grade of Class B misdemeanor or a Class B misdemeanor within the last ten years from the date of the court order.

May not currently be under indictment for any criminal offense.

May not ever have been convicted of an offense above the grade of a Class B misdemeanor or a Class B misdemeanor within the last ten years.

Must never have been convicted of any family violence offense.

May not be prohibited by state or federal law from operating a motor vehicle.

May not be prohibited by state or federal law from possessing firearms or ammunition.

Must be a US citizen.

May not have been discharged from any military service under less than honorable conditions including, specifically; (A) under other than honorable conditions; (B) bad conduct; (C) dishonorable; or any other characterization of service indicating bad character.

May not have had a commission license denied by final order, revoked, currently on suspension for a criminal violation, or have a voluntary surrender of license currently in effect.

College of the Mainland must follow these regulations and cannot make any exceptions.

If you believe that you qualify for an exception you must contact TCOLE directly and provide the College a written letter from TCOLE detailing the issue.

ACCEPTANCE AND CONFIRMATION

Application Acceptance

Application to the academy does not guarantee acceptance. Class space is limited to 24 students.

Students will be accepted by the following priority:

- 1) Cadets who are from Local Police Departments and Sheriff's Offices
- 2) Cadets who are full-time employees of other law enforcement agencies
- 3) Cadets who are sponsored by other law enforcement agencies
- 4) General Public Cadets "Independents" if room is available will be prioritized as follows:
 - (1) Prior military or criminal justice experience
 - (2) Criminal justice degrees / college studies
 - (3) Meet minimum state requirements established by TCOLE

Confirmation of Acceptance

Accepted candidates and/or agency will be notified by the College of the Mainland Law Enforcement Academy once approved.

SPONSORED AND INDEPENDENT CADETS

Sponsored Paid Student:

Sponsored paid students are cadets hired by a law enforcement agency then sent to the police academy to earn their Basic Peace Officer Certification.

If you are working for a Law Enforcement agency and they are not paying you to attend the academy, then you do not qualify as a sponsored cadet and must complete the entire application.

Sponsored Cadets must have their agency fill out a DECLARATION OF LICENSING COURSE ENROLLMENT ELIGIBILITY form. This form declares that that Agency has done the due diligence and has on record the material necessary to show that a cadet is eligible for licensure under Section 217.

Independent Student:

Independent students are cadets who have met all prerequisites but are not hired as full-time employees of a law enforcement agency. This includes cadets that may work for a Law Enforcement Agency but are not being paid to attend the BPOC/Law Enforcement Academy. If you work for an agency but are not being paid to attend, you must fill out the entire packet.

Texas Administrative Code TITLE 37 PUBLIC SAFETY AND CORRECTIONS PART 7 TEXAS COMMISSION ON LAW ENFORCEMENT CHAPTER 217 ENROLLMENT, LICENSING, APPOINTMENT, AND SEPARATION RULE §217.1 Minimum Standards for Enrollment and Initial Licensure

(a) In order for an individual to enroll in any basic licensing course the provider must have on file documentation, acceptable to the Commission, that the individual meets eligibility for licensure.

(b) The commission shall issue a license to an applicant who meets the following standards:

(1) minimum age requirement:

(A) for peace officers and public security officers, is 21 years of age; or 18 years of age if the applicant has received:

(i) an associate's degree; or 60 semester hours of credit from an accredited college or university; or

(ii) has received an honorable discharge from the armed forces of the United States after at least two years of active service;

(B) for jailers and telecommunicators is 18 years of age;

(2) minimum educational requirements:

(Å) has passed a general educational development (GED) test indicating high school graduation level;

(B) holds a high school diploma; or

(C) for enrollment purposes in a basic peace officer academy only, has an honorable discharge from the armed forces of the United States after at least 24 months of active duty service.

(3) is fingerprinted and is subjected to a search of local, state and U.S. national records and fingerprint files to disclose any criminal record;

(4) has never been on court-ordered community supervision or probation for any criminal offense above the grade of Class B misdemeanor or a Class B misdemeanor within the last ten years from the date of the court order;

(5) is not currently charged with any criminal offense for which conviction would be a bar to licensure;

(6) has never been convicted of an offense above the grade of a Class B misdemeanor or a Class B misdemeanor within the last ten years;

(7) has never been convicted or placed on community supervision in any court of an offense involving family violence as defined under Chapter 71, Texas Family Code;

(8) for peace officers, is not prohibited by state or federal law from operating a motor vehicle;

(9) for peace officers, is not prohibited by state or federal law from possessing firearms or ammunition;

(10) has been subjected to a background investigation completed by the enrolling or appointing entity into the applicant's personal history. A background investigation shall include, at a minimum, the following:





(A) An enrolling entity shall:

(i) require completion of the Commission-approved personal history statement;

(ii) verify that the applicant meets each individual requirement for licensure under this rule based on the personal history statement and any other information known to the enrolling entity; and

(iii) contact all previous enrolling entities.

(B) In addition to subparagraph (A) of this paragraph, a law enforcement agency or law enforcement agency academy shall:

(i) require completion of a personal history statement that meets or exceeds the Commission-approved personal history statement;

(ii) contact at least three personal references;

(iii) contact all employers for at least the last ten years, if applicable;

(iv) contact the chief administrator or the chief administrator's designee at each of the applicant's previous law enforcement employers; and

(v) complete criminal history and driving records checks.

(11) examined by a physician, selected by the appointing or employing agency, who is licensed by the Texas Medical Board. The physician must be familiar with the duties appropriate to the type of license sought and appointment to be made. The appointee must be declared by that professional, on a form prescribed by the commission, within 180 days before the date of appointment by the agency to be:

(A) physically sound and free from any defect which may adversely affect the performance of duty appropriate to the type of license sought;

(B) show no trace of drug dependency or illegal drug use after a blood test or other medical test; and

(C) for the purpose of meeting the requirements for initial licensure, an individual's satisfactory medical exam that is conducted as a requirement of a basic licensing course may remain valid for 180 days from the individual's date of graduation from that academy, if accepted by the appointing agency;

(12) examined by a psychologist, selected by the appointing, employing agency, or the academy, who is licensed by the Texas State Board of Examiners of Psychologists. This examination may also be conducted by a psychiatrist licensed by the Texas Medical Board. The psychologist or psychiatrist must be familiar with the duties appropriate to the type of license sought. The individual must be declared by that professional, on a form prescribed by the commission, to be in satisfactory psychological and emotional health to serve as the type of officer for which the license is sought. The examination must be conducted pursuant to professionally recognized standards and methods. The examination process must consist of a review of a job description for the position sought; review of any personal history statements; review of any background documents; at least two instruments, one which measures personality traits and one which measures psychopathology; and a face to face interview conducted after the instruments have been scored. The appointee must be declared by that professional, on a form prescribed by that professional, on a form prescribed by the commission, within 180 days before the date of the appointment by the agency;





(A) the commission may allow for exceptional circumstances where a licensed

physician performs the evaluation of psychological and emotional health. This requires the appointing agency to request in writing and receive approval from the commission, prior to the evaluation being completed; or

(B) the examination may be conducted by qualified persons identified by Texas Occupations Code §501.004. This requires the appointing agency to request in writing and receive approval from the commission, prior to the evaluation being completed; and

(C) for the purpose of meeting the requirements for initial licensure, an individual's satisfactory psychological exam that is conducted as a requirement of a basic licensing course may remain valid for 180 days from the individual's date of graduation from that academy, if accepted by the appointing agency; (13) has never received a dishonorable discharge;

(14) has not had a commission license denied by final order or revoked;

(15) is not currently on suspension, or does not have a surrender of license currently in effect;

(16) meets the minimum training standards and passes the commission licensing examination for each license sought;

(17) is a U.S. citizen.

(c) For the purposes of this section, the commission will construe any court-ordered community supervision, probation or conviction for a criminal offense to be its closest equivalent under the Texas Penal Code classification of offenses if the offense arose from:

(1) another penal provision of Texas law; or

(2) a penal provision of any other state, federal, military or foreign jurisdiction.

(d) A classification of an offense as a felony at the time of conviction will never be changed because Texas law has changed or because the offense would not be a felony under current Texas laws.

(e) A person must meet the training and examination requirements:

(1) training for the peace officer license consists of:

- (A) the current basic peace officer course(s);
- (B) a commission recognized, POST developed, basic law enforcement training course, to include:
 - (i) out of state licensure or certification; and
 - (ii) submission of the current eligibility application and fee; or

(C) a commission approved academic alternative program, taken through a licensed academic alternative provider and at least an associate's degree.

(2) training for the jailer license consists of the current basic county corrections course(s) or training recognized under Texas Occupations Code §1701.310;

(3) training for the public security officer license consists of the current basic peace officer course(s);

(4) training for telecommunicator license consists of telecommunicator course; and

(5) passing any examination required for the license sought while the exam approval remains valid.

(f) The commission may issue a provisional license, consistent with Texas Occupations Code §1701.311, to an agency for a person to be appointed by that agency. An agency must submit all required applications currently prescribed by the commission and all required fees before the individual is appointed. Upon the approval of the application, the commission will issue a provisional license. A provisional license is issued in the name of the applicant; however, it is issued to and shall remain in the possession of the agency.





Such a license may neither be transferred by the applicant to another agency, nor transferred by the agency to another applicant. A provisional license may not be reissued and expires:

(1) 12 months from the original appointment date;

(2) on leaving the appointing agency; or

(3) on failure to comply with the terms stipulated in the provisional license approval.

(g) The commission may issue a temporary jailer license, consistent with Texas Occupations Code §1701.310. A jailer appointed on a temporary basis shall be enrolled in a basic jailer licensing course on or before the 90th day after their temporary appointment. An agency must submit all required applications currently prescribed by the commission and all required fees before the individual is appointed. Upon the approval of the application, the commission will issue a temporary jailer license. A temporary jailer license may not be renewed and expires:

(1) 12 months from the original appointment date; or

(2) on completion of training and passing of the jailer licensing examination.

(h) The commission may issue a temporary telecommunicator license, consistent with Texas Occupations Code §1701.405. An agency must submit all required applications currently prescribed by the commission and all required fees before the individual is appointed. Upon the approval of the application, the commission will issue a temporary telecommunicator license. A temporary telecommunicator license expires:

(1) 12 months from the original appointment date; or

(2) on completion of training and passing of the telecommunicator licensing examination. On expiration of a temporary license, a person is not eligible for a new temporary telecommunicator license for one year.
(i) A person who fails to comply with the standards set forth in this section shall not accept the issuance of a license and shall not accept any appointment. If an application for licensure is found to be false or untrue, it is subject to cancellation or recall.

(j) The effective date of this section is February 1, 2020.

ACADEMY RULES, POLICY AND REGULATIONS

Notice: Further rules and regulations may be explained and delivered in the course orientation, course, or on the syllabus.





UNIFORMS

- Uniforms reflect the cadet's professionalism and entry into the field of Law Enforcement.
- Academy Cadets are expected to be always in uniform while performing class duties.
- Uniforms will require cost in addition to the tuition for the cadet.
- Uniforms will consist of black pants, black duty boots, black belt and police duty uniform shirt.
- Cadets will need to wear a white ring (round) necked undershirt with academy shirt.
- Cadets should avoid purchasing uniform parts until Basic Peace Officer Academy Orientation.
- Specialized uniforms for Physical Training (PT) are also required.
- Cadets are expected to keep their uniforms neat and clean for the academy.
- Uniform inspections will occur before the beginning of class.
- Uniforms will be discussed and explained further in Basic Peace Officer Academy Orientation.
- No firearms will be allowed in the building or on your uniform.





PHYSICAL TRAINING

The COM Law Enforcement Academy PT Program is designed to get the cadet prepared for the following:

- Different course modules presented in the academy
- Law Enforcement Agency Entrance PT exams and assessments
- Law Enforcement personnel Day-to-Day tasks

The PT program is a mandatory portion of the Basic Peace Officer Academy.

This policy is at the discretion of the Academy Director.

PT will occur at the dates and times listed on the class schedule. Cadets should always have their PT material accessible during class.

The only approved exceptions for not attending at PT session is related to the following:

- Function related to the application process for a Law Enforcement Agency.
- Doctor's appointment; and
- Any other reasons must be discussed and approved by the Academy Director or PT Instructor prior to the PT.

The PT program will include periodic agility and fitness evaluations to determine the cadet's level as they progress through the Academy.

BEFORE THE START OF THE ACADEMY

For the law enforcement field, a person must maintain proper nutrition and keep themselves at an elevated level of fitness. This policy is at the discretion of the academy director.

- Prior to the start of the academy, cadets should be able to perform a minimum of 20-25 pushups and 25-30 sit ups with proper form and technique, in one (1) minute.
- The cadet should also be able to handle performing a 35-45-minute cardio workout with few rest and water breaks.
- Cadets should be able to run a $1\frac{1}{2}(1.5)$ mile in under 20 minutes. The goal of the PT $1\frac{1}{2}$ mile run is for each cadet to have a time under 18 minutes and 30 seconds, (18:30).
- There is a timed Obstacle Course run in which the goal is to complete the run in or less than one minute and forty-five seconds, (1:45).





- The weekend prior to the start of the Academy, the cadets should properly hydrate.
- From today until the start of the Academy the cadet needs to start a food intake journal that will list the type and quantity of their daily food intake. This journal will be discussed in the Academy.
- To assist cadets with their preparation for the PT portion of the Academy, the following is suggested:
 - > Use a phone App or work-out program(s) related to running or working out;
 - Examples of these are:
 - My Fitness Pal, Couch to 5K, Run Keeper Phone App
 - P90X, Insanity or Body Beast Programs

The COM PT Program is set-up to progress a cadet from a basic to an intermediate level of fitness by the end of the Academy.

For those cadets who may already be at an intermediate level, the Academy should be viewed as an opportunity for you to move from an intermediate to an advanced fitness level.

EXERCISE GEAR / PT UNIFORM

Physical fitness is vital to the successful career of all law enforcement officers. For this reason, the College of the Mainland Basic Peace Officer Academy has included several days of physical training. The participants will be required to furnish suitable gear for this training.

Necessary Gear:

Good Running Shoes

Navy Blue Shorts

White t-shirt with 1' letters on front right part of shirt that has the cadet's first initial and last name.

The back of the white t-shirt will have the cadet's last name in 3' letters.

The cadet needs to use a sharpie or black marker to print names on t-shirts. Females must

wear dark colored shirts or sports bra under white t-shirt.

Hat and sunglasses are permitted

The required running and physical training are very strenuous.





ATTENDANCE

- Class will begin promptly at assigned times.
- Cadets will be required to remain in class until dismissed the end of the instruction day, unless otherwise excused by the scheduled instructor or academy personnel.
- The Academy will maintain a permanent record of all absences and tardiness on the class roll.
- An excessive accumulation of tardiness and/or absenteeism determined by the Academy Director to be detrimental to the academy and/or state requirements of the BPOC will result in dismissal from the academy.
- Students will be required to make up any time and /or learning objectives missed.





APPEARANCE

- Cadets are required to wear the assigned uniforms to all classes and activities unless otherwise directed by the instructor or academy personnel.
- Uniforms will be clean, fresh in appearance and pressed.
- Boots will be polished and clean at all times.
- Only sunglasses approved by the COM Basic Peace Officer Academy will be worn with the uniform.
- Sunglasses will be removed while in the classroom and at no time will be worn on top of the head.
- Jewelry may be worn in moderation. Generally, a wedding ring and a watch are acceptable.
- All jewelry may have to be removed at the discretion of the instructor for safety reasons.
- No facial hair is permitted.
- Sideburns will not extend below the middle of the ear lobe.
- Male hair is to be kept short, neatly trimmed in a manner not to touch the ear or the shirt collar.
- Female cadets will wear their hair pulled back to meet the requirements for all cadets.
- Cosmetics may be worn in moderation.
- Tattoos that are visible will require the cadet to wear a navy blue, long sleeve Under Armor type garment beneath his/her uniform shirt. Tattoos will not be visible.
- Students will be expected to wear the required standard uniform while training or in class except when permission is granted from the Instructor or Academy Director.





CLASSROOM DEMEANOR

- Cadets will always maintain attentive posture in class and pay strict attention to the instructor.
- Proper respect will be always provided to instructors.
- Cadets are not to speak without first raising a hand and being recognized by the instructor.
- Cadets are not allowed to bring food in the classroom without permission.
- Cadets are not allowed to eat food in the classroom without permission.
- Cadets are not allowed to eat food in the classroom when an instructor is teaching.
- The instructor may on occasion approve the cadets to have a beverage in the classroom.
- Cell phones should be off in the classroom. Cadets waiting on urgent messages must have the phone
 on vibrate. These devices interfere with the right of other cadets to receive instruction and will not be
 tolerated. *Intentional disregard of this rule may result in the dismissal of the offending cadet from
 the academy*. Cadets can be contacted in emergencies.
- Cell phones should be off in the classroom, and will not be allowed on tables, or in hands.
- Cell phones can not be accessed or checked at any time while class is in session.
- Any cadet with their phone on their person during any test or quiz will receive disciplinary action up to and including dismissal from the Academy.
- Any cadet in an emergency service that may receive dispatches on their phone may place their phone on the instructor desk while on duty.
- Behavior that is deemed to be disruptive or disrespectful or interferes with the high standards of this Academy will not be tolerated and may result in dismissal.
- There is no smoking at this college or Academy. No tobacco use of any kind is permitted on college grounds. This is a drug free, and tobacco free campus and all rules and regulations apply.
- No vaping is allowed on this campus and is strictly prohibited.
- Any willful violation of these rules and regulations can result in dismissal from this academy.
- The Academy reserves the right to conduct random drug test at the cadet's expense throughout the entire training cycle.





ACADEMIC REQUIREMENTS

- Cadets will be required to take a multitude of tests.
- Academic tests will be over the comprehensive BPOC learning objectives.
- Spelling tests will also be given. Spelling words will be taken from a list provided to all Academy cadets.
- A minimum passing score of 70% must be obtained on <u>all</u> tests.
- Students will be allowed **one** re-test during the Academy.
- Failure to pass the re-test or a failing score on a second spelling or academic test **may** result in the cadet being dismissed from the Academy.
- A final test will be given at the end of the Academy. Cadets must pass the final with a minimum score of 70% to be eligible to take the TCOLE licensing test.
- Valedictorian is determined by the highest average on academic exams, if a tie occurs the spelling average will break the tie.
- The academic integrity policy of this college is also the policy of this Academy.





FIREARMS

- Students will be required to qualify on a day and night course.
- The primary firearms instructor will set courses of fire in advance to comply with TCOLE BPOC requirements.
- Students must obtain the minimum TCOLE proficiency score on a pass-fail basis in all final firearms qualifications as well as all driving qualification courses to continue in the Academy.
- Failure to meet the minimum firearms or driving standards will result in dismissal from the Academy.
- Any failure to obey range commands or range personnel will result in immediate dismissal from that day of instruction and may lead to dismissal from the course.
- Firearms will be provided to the cadets by the Academy. No personal firearms will be allowed anywhere in the college whether or not the cadet has a state license to carry or not. This is a safety measure put in place as we are a law enforcement training facility. No exceptions unless expressly authorized by the Academy Director.





GENERAL

- The Basic Peace Officer Academy consists of a multitude of strenuous activities and a cadet must be always physically and mentally fit.
- A cadet must participate in all physical fitness activities conducted by the Academy.
- Refusal to fully participate, unless directed by a physician, will result in dismissal from the Academy.
- All Cadets must FULLY participate in all PT related activities at an acceptable level and/or show improvement as determined by the PT instructor.
- Disrespect toward an instructor, COM program staff member, COM Personnel or other cadets or guest speaker will not be tolerated and may result in dismissal.
- Cadets are expected to follow lawful directives by those of the class leader(s), staff, instructors, supervisors.
- Cadets will rise when any commissioned personnel or COM personnel enter their classroom.
- All media related issues and contact must be channeled through the Academy staff or their law enforcement agency.
- Cadets are to always address all instructors and academy personnel in a respectful manner. Yes Sir, No Sir, etc.
- Cadets will not address instructors by their first name. They will use an honorarium and last name.
 - Mr. Instructor, Professor Instructor, Constable Instructor, Officer Instructor, Deputy Instructor etc.
- Academy staff will not discuss cadet grades, matters, etc. with anyone except the cadet or their law enforcement agency.
- No firearms are to be brought to class. No personal firearms or weapons of any kind allowed on college property.

- Cadets are preparing to enter Law Enforcement and are expected to conduct themselves in the Academy with the highest conduct and good citizenship. Any violations will be investigated by Academy staff and appropriate disciplinary measures taken up to and including dismissal from the Academy.

Whether in class off campus, in the public or out of uniform. Any violations will be investigated by Academy staff and appropriate disciplinary measures taken up to and including dismissal form the Academy.

During the Basic Peace Officer Academy there will be time set aside for physical training, conditioning and other activities that require *strenuous physical exercise*. These activities may include a variety of stretching exercises and calisthenics, strenuous aerobic activity, sit-ups, push-ups, pull-ups, running up to six miles, sprinting, self-defense tactics, climbing, jumping, rolling, lifting, and dragging.

You must be physically capable of fully participating in these types of activities. <u>All cadets</u> <u>must participate in all PT related activities at an acceptable level and/or show improvement as</u> <u>determined by the PT instructor</u>. <u>Failure to fully participate will result in your dismissal from</u> <u>the Academy</u>.

If you have any doubts about your health or any physical conditions that may prevent you from participating in the above-mentioned activities, **consult your physician prior** to enrolling in the academy. The Academy requires all cadets to obtain a signed statement from a physician that he/she has been drug screened and can safely complete all the physical requirements of Academy training

(See TCOLE L-2 form).

All physical conditioning and training activities will be conducted with due regard for participant safety.

I certify that I have no preexisting physical or medical conditions such as pregnancy, allergies, physical impairment, respiratory condition, heart condition, diabetes, excess weight to height ratio, drug addiction, or any other condition which requires medication or the care of a physician that will prevent me from fully participating in the required physical activities described above for the duration of the academy.

I further certify that as a willing participant I will not hold the academy or its representatives or agents liable for any injury I may receive during my participation in this training.
