

**Course Syllabus: BEAD STITCHING**

**Course Description**

Learn three new stitches or techniques for doing bead work.

**Required Supplies**

Bead mat, scissors, beading needles size 10 and 12's, beading thread, ruler, pencil, paper for notes.

**End-of-Course Outcomes**

Upon successful completion of this course, students will: complete 3 projects using 3 different stitches learned in class.

**Course Outline**

**Week 1:** Introductions and review of COM safety procedures; discuss syllabus and course materials. Demonstrate stitch to be learned. Students will begin sampler of stitch and chose a project to complete that uses the stitch.

**Week 2:** Complete sample and begin work on project chosen in Week 1. Discuss different types of thread and when to use them.

**Week 3:** Discuss methods of completing project. Discuss types of clasps.

**Week 4:** Finish project. Begin discussion of next stitch.

**Week 5:** Demonstrate new stitch. Students begin sample of new stitch. Chose new project for new stitch.

**Week 6:** Complete sample of stitch. Begin project chosen in Week 5.

**Week 7:** Work on project.

**Week 8:** Discuss finishing techniques for these projects. Complete project.

**Week 9:** Demonstrate new stitch. Students begin sample of new stitch. Choose new project for the new stitch.

**Week 10:** Finish sample of new stitch. Begin project chosen in Week 9.

**Week 11:** Work on project. Discuss finishing techniques for these projects.

**Week 12:** complete current project and any incomplete projects from the semester.
